Preparation: It is *extremely* important that you read the course materials prior to attending the class. Failure to study the materials before the course commonly leads to failure of the exam

Certification: Those taking the course are eligible to take the Playground Safety Inspectors Exam after the course. Upon successfully passing the exam, you will be certified through the National Recreation and Park Association as a Certified Playground Safety Inspector (CPSI) for a three year period. Certificates will be awarded and your name will be added to a national roster of CPSI's.

ADA Accommodations: A candidate who has a disability may request a special accommodation. The request must be submitted in writing at the time of course or exam registration. The request form is available online at www.nrpa.org/cpsi In order to properly accommodate all persons with disabilities, it is recommended that all requests be made 45 days prior to the scheduled date for the course and exam.

ESL Accommodations: English as second language (ESL) candidates may request a time extension and/or the use of a strict translation dictionary. Candidates request forms/fees must be submitted to NRPA no less than 30 days prior to the exam. The request form is available online at www.nrpa.org/CPSI.

Continuing Education Units: Earn 1.5 CEUs's while participating in this seminar. NRPA will forward you a transcript of your attendance 6 to 8 weeks after the course

Blended Learning Schedule

- ⇒ TRPA receives your registration and payment – Once we reach the minimum of 20 - TRPA will send information to NRPA and ship your books to you.
- ⇒ NRPA receives information from TRPA – NRPA will have you entered in their Online Learning System.
- ⇒ You will receive an email from NRPA with your credentials to log in to their Online Learning System. From this date you will have access for to the program. You must complete this no less than 24 hours before the Virtual Learning Session
- ⇒ You study and participate in the Online Learning Center
- ⇒ You participate in the Live Virtual review and question and answer session with a CPSI instructor on June 22.

- ⇒ Upon passage of the exam, NRPA will send you your certificate.
